- Multi-Day Tours: <u>Unless otherwise noted on the tour brochure</u>, a deposit of \$150 per person is due within 5 days to confirm your reservation, and final payment is due 90 days prior to the tour departure date. 89 days or less prior to departure, your tour cost payment is non-refundable.
